6. - (c) The TRUSTEES may borrow or raise moneys or funds form banks financial institution government, other institutions, persons firms and companies for the purpose and the objects of the trust, on such terms and conditions as they may think fit in the interest of the trust and mortgage, pledge or otherwise secure all or any of the properties investments of the trust as a security against such borrowings.
